



## Fund Overview

The fund aims to deliver an annualised net return of 7% to 8% over the medium to long-term in anything but the bleakest of market conditions. It will do so via an actively managed exposure to a diversified portfolio of defined return investments linked to global equity indices. It invests primarily in UK Government Bonds to provide the return of capital to investors over time, alongside a portfolio of global, liquid derivatives that generate the return on capital. Due to the nature of the investments, the fund's behaviour in different market scenarios should be more predictable and the returns more probable.

## Monthly Commentary

Global equity markets pulled back a little in October, particularly towards the end of the month when bond yields rose as investors priced in a slower reduction in interest rates in the US and Europe looking forward. The Fund is mainly exposed to the UK, US and EU large cap markets which for the month were all down 1.48%, 0.74% and 3.2%. The Fund was down 0.5% for the month which makes sense as the current sensitivity ('delta') to market moves is around a third. During the month four autocall investments matured, three on their first anniversary and one on its second anniversary, with an average coupon of 9%. Four new trades were added with an average coupon of 8.7%. Terms on new trades are still very good but a year ago were even better when interest rates were a little higher. Despite the equity market pull back at the end of October the downside protection to the worst performing index to a positive return was still a substantial 31.7%, with average capital protection to the worst performing index being 36%. Looking forward the Fund remains well positioned to achieve its aim of 7-8% in anything but the bleakest of market conditions.

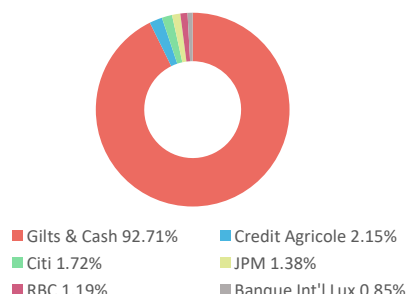

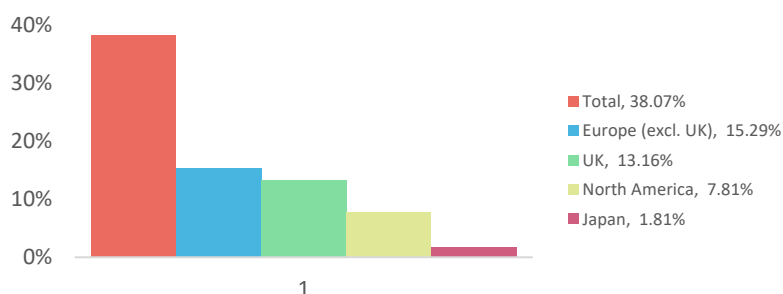

Forward Looking Scenario Analysis and Intrinsic Value

Estimated Fund Move or 'Intrinsic Value'

The intrinsic value is the aggregate terminal value of the fund considering estimated fees over the relevant period. The table above shows that, for example, if an investor bought the fund today and none of the markets on which the investments were based moved between now and when the investments mature, the fund would increase by 11.53%, a terminal value of GBP 2.3000 (based on current NAV of GBP 2.0623). What this does not tell us is the yield that is represented by these intrinsic values.

Average Time to Holdings' Maturity or Duration

The table above also shows the weighted average time to maturity of the investments held within the fund. Currently this is 1.29 years because, at current market levels, most of the current investments are likely to mature

within 1-2 years. This number gives the investor an idea of how long it will take for them to earn the Equivalent Annualised Return.

Equivalent Annualised Return or Intrinsic Value (Annualised)

The table also shows the current expected return of the fund considering estimated fees for certain movements in the underlying indices. For example, if markets do not move, we would expect the fund to yield 8.80% given its current make-up. You can also see that we would expect a positive return if the market falls 20% and then stays at that level until all investments mature.

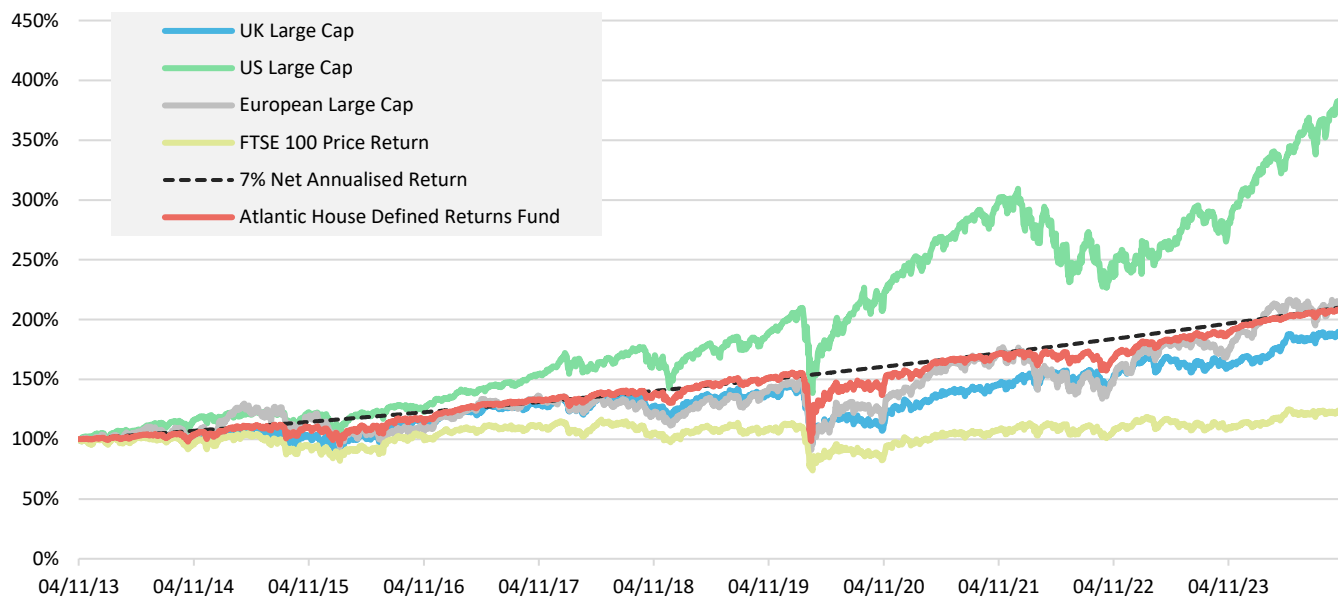
